(Under Chapter 1702 of the Ohio Revised Code)

Non-Profit Corporation

The undersigned, desiring to form a corporation, not for profit, under Sections 1702.01 et seq of the Ohio Revised Code do hereby state the following:

FIRST. The name of said corporation shall be: The African Solar Village Project, Inc.

SECOND. The place in Ohio where its principal office is to be located is 6802 Carnegie #4, Cleveland : Cuyahoga County, Ohio

THIRD. The purpose(s) for which this corporation is formed is : see attached

ARTICLE THREE
