### ADDITIONAL PROVISIONS TO CERTIFICATE OF AMENDMENT OF DOMINICAN COMMUNITY SERVICES Charter Number 580051

RESOLVED, that Article SECOND of the Articles of Incorporation of the Corporation is amended in its entirety to read as follows:

"SECOND. The location of the principal office of the Corporation is 425 Ezzard Charles Drive, Cincinnati, Hamilton County, Ohio."

RESOLVED, that Article THIRD of the Articles of Incorporation of the Corporation is amended in its entirety to read as follows:

"THIRD: The purposes for which this Corporation is formed are:

- 1. To provide health and human services to poor and disadvantaged persons and families without regard to race, religion, age, sex or national origin. These services may be of a preventive, therapeutic, rehabilitative, educative and/or supportive nature.
- 2. To work cooperatively with individuals, families and other community groups to initiate and support social change for the alleviation of injustices and the attainment of basic human rights.
- To work cooperatively with other health, welfare, research, planning and educational organizations to provide for more comprehensive community services.
- 4. To encourage and provide opportunities for the education of those engaged in this work as well as the general public.
- 5. To carry on or pursue any lawful act, activity, or purpose for which corporations may be formed under Chapter 17Q2 of the Ohio Revised Code, provided that such purposes qualify the corporation as an exempt organization under Section 501 (c) (3) of the Internal Revenue Code of 1954(or the corresponding provision of any future United States revenue law)."
