### To Whom it May Concern:

In compliance with Ohio Revised Code Section 1701.87, Capitol Advocates, Inc. hereby issues the following notice of dissolution to all creditors and claimants against the corporation. Due to a change in ownership, Capitol Advocates, Inc. will be dissolved and reconstituted as a new corporation under the same trade name, Capitol Advocates, Inc. with new corporate officers.

#### **Notice of Dissolution**

While there are no known creditors with pending claims against Capitol Advocates, Inc., ORC 1701.87 nonetheless requires a notice of dissolution with the following terms and conditions:

- All claims against Capitol Advocates, Inc. must be presented in writing and shall identify the claimant and contain sufficient information to reasonably inform the corporation of the substance of the claim;
- All claims shall be sent to:

- All claims must be received by November 20, 2012. Any claim received after this deadline will
  not be considered.
- The corporation maintains the right to make distributions to other creditors or claimants, including distributions to shareholders or the corporation, without further notice to the claimant.
- Giving any notice or making any offer under ORC 1701.87 shall not revive any claim then barred
  or constitute acknowledgement by the corporation that any person to whom the corporation
  sent notice under this section is a proper claimant and shall not operate as a waiver of any
  defense or counterclaim.
- A claim is barred if a claimant that was given notice of dissolution under ORC 1701.87 does not deliver the claim to the dissolved corporation by the deadline stated in the notice.
- A copy of this notice shall be posted on the Ohio Secretary of State website.
