#### MINUTES OF THE ANNUAL SHAREHOLDER MEETING OF EVANGELICAL COMMUNICATIONS CORPORATION FOR DISSOLUTION

Held at the Office of the Company January 22, 2013

The Annual Meeting of the sole Shareholder of Evangelical Communications Corporation was held at the Offices of the Company on January 22, 2013.

David H. Bellis, Director of the Company, called the meeting to order and presided as Chairman. Rebekah K. Bellis, Secretary of the Company, acted as Secretary of the meeting.

The Director reported on and reviewed the general operations and business of the Company for the fiscal year ended December 31, 2012.

The Director submitted financial statements including therein an operating statement, setting forth a summary of Income and Expenses for the fiscal year ended December 31, 2012, and a Balance Sheet setting forth a summary of the Assets and Liabilities of, and the Shareholder's Equity in, the Company as at the close of business on December 31, 2012. The Director's Report and Financial Statements were duly approved.

The sole Shareholder then proceeded to call for the dissolution of the corporation due to lack of business. It was documented that the corporation has no indebtedness.

Pursuant to the authority of Section 1701.54 and 1701.86 of the Ohio Revised Code, the undersigned, being all of the directors of the corporation hereby consent to the following action:

RESOLVED: That the Articles of Incorporation of Evangelical Communications Corporation be dissolved on January 31, 2013 with the filing of appropriate tax and dissolution forms with all required government agencies immediately thereafter. The sole Shareholder agrees to be responsible for any and all past debts of the corporation that may arise.
