ARTICLES OF INCORPORATION
(Under Chapter 1702 of the Ohio Revised Code)
Non-Profit Corporation

The undersigned, desiring to form a corporation, not for profit, under Sections 1702.01 et seq. of the Ohio Revised Code, do hereby state the following:

FIRST. The name of said corporation shall be SHEPHERD'S VOICE MINISTRY

SECOND. The place in Ohio where its principal office is to be located is 15 SOUTH LIBERTY STREET

POWELL (city, village or township) (OHIO) DELAWARE County, Ohio.

THIRD. The purpose(s) for which this corporation is formed is:

THE PURPOSE FOR WHICH THIS CORPORATION IS ORGANIZED ARE:

- 1) *To glorify the Lord Jesus Christ*

- 3) *To bring men and women into a personal knowledge of Jesus Christ as their Lord and Savior.*
