These articles of incorporation of Fort Meigs Sertoma, Inc., witnesseth: that we the undersigned, all of whom are citizens of the State of Ohio and of the United States of America, desiring to form a corporation not for profit under the general corporation laws of the State of Ohio, do hereby certify:

First. The name of said corporation shall be Fort Meigs Sertoma, Inc.

Second. Said corporation is to be located, and its principal business transacted at Toledo in Lucas County, Ohio.

Third. Said corporation is formed for the purpose of investigating, assisting, providing relief and promoting the general welfare of the youth, poor and needy in Toledo, Ohio and vicinity; for raising and receiving funds by the enterprise and labor of said corporation's members, or by gift or bequest from others; for disbursing the benefits either as money or property, or in the labors of its members, to recipients duly selected by the membership, and for doing all things necessary or incident thereto.

Fourth. The names and post office addresses of said corporations trustees who are to serve until the first meeting to be called for the regular election of trustees are:
