

(Under Chapter 1702 of the Ohio Revised Code)
Non-Profit Corporation

The undersigned, desiring to form a corporation, not for profit, under Sections 1702.01 et seq. of the Ohio Revised Code, do hereby state the following:

FIRST. The name of said corporation shall be _____

SECOND. The place in Ohio where its principal office is to be located is 31 S. Cedar St.

Troy, Miami County, Ohio

THIRD. The purpose(s) for which this corporation is formed is:

To aid, assist, encourage, and mentor Tri-County black minority business projects through charitable contributions, and generally doing any and all things necessary or incident thereto.

(a) to acquire by purchase, lease, exchange or otherwise, to own, hold, use, manage, develop, plat, improve, and to sell, lease, mortgage, exchange and otherwise deal in, real estate and any interest or right therein either for its own account or for the account of others; to erect, construct, rebuild, repair, manage and control, lease, by and sell, any and all kinds of buildings, factories, shops, warehouses, offices, houses, apartment buildings and structures; and to engage generally in the business of or operating and leasing real estate of every character and description.

(b) To do all such further acts as are necessary and convenient or expedient to accomplish the foregoing purposes or as are incidental thereto.

Each purposes specified in any clause or paragraph contained in this Article Third shall be deemed to be independent of all other purposes herein specified and shall not be limited or restricted by reference to or inference from the terms of any other clause or paragraph of these Articles of Incorporation.
